





Where are the Magistrates Court? The Criminal Division of the Magistrates Court is a Court of Summary Jurisdiction [Vé © Ace the Law of the Court of First Instance of 1991 S 7(2)] and it is the Court of origin for the matters that must be heard in the Superior Courts. The Court has jurisdiction for: a magistrate cannot condemn greater than 150,000 dollars (or a fine of more than 300,000 dollars for a crime typified in the 2012 Labor Health and Safety Law (SA), regardless of whether the crime is summary or accused [v © ace the law of the Court of Magistrates of 1991 (SA) S 9(a), 9 and 9(a), 9(a) and 9.4]). A magistrate may send the imposition of a sentence to a superior court if the magistrate considers that the sentence imposed must exceed the aforementioned numbers [v © The Law of the Court of First Instance of 1991 (SA) S 9(7) or When the magistrate is that the interests of justice demand the commission to a superior court [v © the Criminal Procedure Law of 1921 (SA) S 116 (1)]. If a person declares himself not guilty of a crime charged in the Court of Magistrates, but guilty of an alternative crime or an attempt to commit the accused crime (and the guilty imputation is accepted by the prosecutor) the court could condemn a person.
